This is regarding Compliance Report submitted by Smt. Kishoritai Bhoyar College of Pharmacy, Behind Railway Station, New Kamptee, Dist. Nagpur – 441002, Maharashtra for the UG-Pharmacy program which was accredited by NBA for academic years 2018-19 to 2020-21 whose validity of accreditation had expired on 30/06/2021. Nagpur – 441002, Maharashtra** should submit fresh online application under SAR January, 2016 document through e-NBA portal at least five months before the expiry of validity of accreditation mentioned above.
